



## 5 -YEAR LIMITED WARRANTY

*Silescent Lighting Corporation (Company) warrants to the original user that products sold will, upon shipment, be free of defects from manufacturing and continue normal operation without default for a period as identified above for the related product after date of invoice. Normal operation shall be considered as full functional control (on/off and dimming), with default described as failure to turn on, failure to remain on without flashing or experiencing erratic behaviors or failure to dim properly. The Company's liability only applies to the repair and/or replacement of the defective parts. Repair or replacement will be the sole option of Silescent Lighting Corporation. **WARRANTY IS VOID IF PRODUCT IS NOT USED FOR THE PURPOSE FOR WHICH THIS PRODUCT IS MANUFACTURED AND IN ACCORDANCE TO ITS OPERATING SPECIFICATIONS AND INSTALLED IN ACCORDANCE TO MANUFACTURER'S INSTALLATION INSTRUCTIONS.** Warranty does not apply to products that have been altered or repaired outside of the Company's factory or have been subject to abuse, improper voltages, mishandling, neglect, misuse, improper installation/electrical connection, improper product selection or accident (including shipping damages or effects due to installation). Silescent Lighting Corporation shall not be liable to the purchaser or to any third party for any indirect, special consequential or incidental losses or damages (electrical or mechanical) pertaining to its installation or use. Purchaser's sole remedy is to seek replacement or repair of the product from the Company. Replacement products will be equivalent in function, but may not be identical to the replaced product. Auxiliary equipment furnished by the Company carries only the warranty of the manufacturer thereof.*
